Who we are

The European Trade Union Liaison Committee on Tourism (ETLC) was set up as a coordination platform in Brussels in 1995 by the European Industry Federations and the Global Union Federations representing workers in the tourism sector.

The European federations EFFAT, ETF and UNI-Europa represent more than 9 million trade union members in Europe. They are the recognised representatives for their sectors with the European institutions and in the European Social Dialogue with employers' organisations.

The European Trade Union Liaison Committee on Tourism represents workers in the various businesses providing services to tourism, such as hotels and restaurants, catering, transport, travel agencies, tour operators, leisure parks, tourist offices, tourist guides, etc.

What we want

Representing this broad base of tourism workers, the ETLC aims to ensure that decision makers at European level are aware of the specific interests and needs of the workforce in tourism, and to speak - whenever possible- with one voice.

Pursuing the overall aim to promote the creation of sustainable employment in tourism, the main objectives of the ETLC are:

- to improve working conditions for tourism workers
- to promote basic and continuous vocational training in the tourism industry
- to promote the Social Dialogue in the tourism sector
- to strengthen cross-border cooperation between trade unions representing workers in the tourism sector
